The property at 1200 Waters Place is a 460,000-square-foot modern office building featuring three floors of Class A office space and a host of outstanding amenities including a full-service Café with landscaped courtyard, Fitness Center, Teleconference Center, Child Care Center, Sundry Shop and abundant parking.

Another long-time major tenant at 1200 Waters Place, the Visiting Nurse Services of New York, has renewed and expanded its long-term lease at the property to 8,400 square feet. Hutchinson Metro Dental has also extended and expanded their long-term lease at the property to nearly 5,000 square feet. Cushman & Wakefield represented VNS in the expansion.
